agree to the following terms and conditions as an Affiliate of the Australian School Canteen Association Company Limited (ASCA):-

- (a) That the three core product categories are:
  - 1. Carbonated soft drinks, mineral & spring waters & sport drinks
  - 2. Savoury snacks, chips etc
  - 3. Ice Cream & related products
- (b) That I will exclusively purchase only from the company that is the current ASCA preferred supplier in the three core product categories, provided that the current ASCA preferred supplier can deliver to the geographic area where the school is located.
- (c) That ASCA does not attempt to influence what is sold in the school canteen, as each School/College has its own canteen policy, however Affiliates agree to exclusively use the designated ASCA preferred supplier for the three core product categories if the canteen sells the products supplied by them.
- (d) That I may purchase from any of the current ASCA optional preferred suppliers, provided that the current ASCA optional preferred supplier can deliver to the geographic area where the school is located.
- (e) I understand that if I breach the requirement to exclusively purchase from the current ASCA preferred supplier for the three core product categories ASCA will terminate my right to receive the discounts from all product categories
- (f) Other than as provided for under clause (e) of this agreement, either party can terminate this contract by giving one month written notice to the other party of their intention to terminate.
